#### Recommendation

It is recommended that your Board adopt the attached resolution approving and adopting a Flag/Proclamation Policy.

### **Discussion**

The Oceano Community Services District (District) was formed in 1981. Unlike Counties or Cities that are authorized to expend funds and provide a wide range of services to its residents, the Oceano Community Services District is a Special Purpose District authorized to expend funds and provide only a few specific services. Those services are water, sewer, fire protection, solid waste, street lighting, and parks & recreation. Expending funds for any other purpose that is not related to these specific services is inappropriate at least, illegal at worst.

Since its inception, the District has a practice of only flying the American Flag and California State Flag on District properties. Additionally, the District does not have a practice of issuing proclamations recognizing various days, weeks, months, or other occasions. There is currently no policy that addresses which flags to fly or which proclamations to issue. The attached proposed Policy is intended to formalize the District's past practices and ensure that District tax and fee revenue is expended for the purpose collected and on active powers of the District. But most importantly, the policy is intended to ensure that no individual or group is discriminated against.

# **FLAG/PROCLAMATION POLICY**

# OCEANO COMMUNITY SERVICES DISTRICT

## 1. PURPOSE

The purpose of this Policy is to establish which flags are authorized to be flown on property owned, leased or controlled by the Oceano Community Services District (herein referred to as District). Additionally, this Policy establishes which proclamations are appropriate to be placed on the agenda of the District Board of Directors for consideration.

### 2. SCOPE

This Policy applies to all properties owned, leased, or controlled by the District, and to all agendas of the District Board of Directors and subcommittees thereof.

### 3. OBJECTIVES

The primary objective is to ensure that no individual or group is discriminated against by allowing the flags or proclamations for one individual or group over other individuals or groups. Other objectives include formalizing the past practices of the District and ensuring that District tax and fee revenues are expended for the purposes collected and on active powers of the District.

## 4. AUTHORIZED FLAGS

- I. The American Flag.
- II. The California State Flag.

### 5. PROCLAMATIONS

The only proclamations authorized to be placed on the agenda of the District Board of Directors for consideration are those that, as determined by the General Manager, are directly related to the active powers of the District. The active powers of the District are those expressly recognized for the District by the San Luis Obispo Local Agency Formation Commission.
