Subject: Agenda Item #5: Appointment to fill the vacancy on the Board of Directors.

Recommendation

It is recommended that your Board make an appointment to fill the Board vacancy that resulted from the Board resignation of Director Replogle that was effective March 23, 2022, for the remainder of the period through the November 2022 election.

Discussion

The resignation of Director Replogle results in the need for your Board to consider filling the vacancy by appointment. Since the resignation was greater than 130 days prior to the next general election in November 2022 the Board may fill the vacancy for an interim period, but not for the remainder of Directors Replogle's term. An appointment to fill the vacancy will therefore be for a limited duration of approximately seven (7) months until the November 2022 election. The ballot in November will include the vacancy and the person elected, once qualified, will fill the remainder of Director Replogle's term (two years).

At the April 13, 2022, meeting your Board gave staff direction to post a notice of the vacancy for fifteen (15) days and to invite applications to fill the open position for the interim period. As a result, three (3) applications were received and are attached. All candidates live in the District boundaries and one candidate is a resident of the District's Division 4, which will become effective with the 2024 election. Because Director Replogle was elected At-large in 2020, any appointment to fill the vacancy, as well as the election in November 2022 to fill the remainder of her term, will be done Atlarge. Subsequent elections, beginning in November 2024 for the newly created Division 4 Board position, will be held by-division.
